



ELECTRONICS RECYCLING AT UCRRA

The NYS Electronic Equipment Recycling and Reuse Act went into effect on April 1, 2011. The law ensures that every New Yorker will have the opportunity to recycle their electronic waste in an environmentally responsible manner. Regardless of where you bought it, what brand it is, or how old it is: bring it to us! We'll make sure it's properly and safely recycled.

WHO CAN RECYCLE E-WASTE AT UCRRA?

- Residents of any town or county, no ID or proof of residence required
- Businesses with less than 50 employees
- Non-profit organizations with less than 75 employees

WHEN CAN I DROP OFF E-WASTE?

- Monday through Friday, 8:00am - 3:00pm
- E-waste is NOT accepted on days that the Main Office is closed, such as holidays

IS THERE A CHARGE TO RECYCLE E-WASTE?

- No, it is absolutely FREE!

WHERE DO I BRING MY E-WASTE FOR RECYCLING?

- Come directly to the **Main Office** located at **999 Flatbush Road in Kingston, NY**. We will direct you to the electronics collection area after you have been checked in
- DO NOT bring electronics into the Agency Office

PLEASE ALSO NOTE THE FOLLOWING:

- You must check into the Main Office each time you bring electronics for recycling.
- Residents may also be able to use their local Town Transfer Station or retail locations such as Best Buy, Staples, or Goodwill to recycle e-waste. Please contact them directly to see if they have an electronics recycling program

<ul style="list-style-type: none"> • Answering Machines • Audio Equipment (Speakers, Microphones, DJ Equipment, Receivers, Recording Devices, Headphones, etc.) • Business/Office Consumer Electronics • Cables/Wires/ Power Cords/Power Strips/Routers, etc. • Calculators • Carbon Monoxide Detectors (Stand-Alone ONLY, Not Combined with Smoke Detector, Batteries Must be Removed) • Cell Phones & Chargers, Corded/Cordless Phones • Christmas Lights/Decorative String Lights • Circuit Boards and Other Intact Computer Parts • Communications Equipment • Computers (Desktops & Laptops) including CRT, LED, LCD monitors • Copiers/Fax Machines • Fans • GPS Units • Ink/Toner Cartridges • Laboratory Equipment • Medical Testing Equipment • MP3 Players • Pagers • Printers (Including Ink & Toner) • Radios/CD Players/Stereo Equipment, etc. • Scanners • Small Kitchen Appliances (i.e. Microwaves, Blenders, Mixers, Coffee Makers) • Storage Devices (External Hard Drives, SD Cards, Memory Cards, Card Readers, etc.) • Tablets • Televisions (CRT, LCD, LED, Plasma, 3D) • Typewriters • Vacuums (with bag removed/canister emptied) • Video Equipment (Cameras, Video Cameras, Web Cams, Recording Devices, etc.) 	<ul style="list-style-type: none"> • Anything Disassembled or Containing Broken Glass • Dry Cell Batteries (Alkaline, Nickel/Cadmium (NiCd), Nickel Metal Hydride (NiMH), and Lithium) • E-Media (CD's, DVD's, floppy discs, VHS tapes, 8-track tapes, cassette tapes, records, etc.) • Freon Containing Devices/Appliances (Air Conditioners, Refrigerators, Dehumidifiers) • Gas Powered Equipment • Household Hazardous Waste • Large Appliances (Washers, Dryers, Stoves, Dishwashers, etc.) • Lighting/Light bulbs/Ballasts (Not Including Christmas Lights) • Materials Leaking Fluid • Materials/Devices Containing Liquids • PCB Containing Materials • Radioactive Materials • Smoke Detectors • Soda Streams • Wet Cell Batteries • Yard/Lawn Equipment
