RESIDENTIAL TRASH PICKUP IN ULSTER COUNTY

The Ulster County Resource Recovery Agency is a commercial facility and **DOES NOT** offer curbside pick-up or dumpster service. Please read on for a list of companies that do offer curbside pick-up in Ulster County, with some of them offering dumpster service as well.

Each company has their own service area, pricing, and rules as to what they do/do not accept. Check around to find the right company for you.

Alternatively, if you are a resident who chooses not to use a waste hauler for curbside pickup, you may also consider utilizing your local town transfer station to drop off your trash and recycling. A list of these transfer stations is available on our website at www.UCRRRA.org.

2019 PERMITTED MSW HAULERS

In Ulster County, municipal solid waste (MSW) is regulated by Flow Control (Local Law No. 10 of 2012), meaning all MSW generated in Ulster County must be brought to the Ulster County Resource Recovery Agency. Haulers who pick-up MSW in Ulster County must be permitted through the Agency.

All of the following haulers have completed the Agency's Flow Control Application for 2019 and have been permitted to collect and dispose of MSW in Ulster County.
